ANNUAL REPORT OF EXAMINATION 2023-24

- This annual report is placed in the Twenty-Eight Academic council meeting.
- Examinations were conducted in accordance with SOP for conduct of examination by SSAHE. as per the guidelines.
- The examinations were closely monitored by Chief Superintendent, Deputy Chief Superintendent, Room Superintendent and Invigilators.
- Proper seating arrangements were done to prevent examination related malpractices.
- Examination was conducted under CCTV surveillance and tight security outside exam hall.
- Custodian, Coding officer and technical staffs were appointed.
- Answer scripts were coded to mask the identity of answer booklet.
- **Medical:**
 - UG – Two valuations - Two external and two internal examiners.
 - PG – Four valuations - Two external and two internal examiners.
- **Dental:**
 - UG - Two valuations - One external and one internal examiner.
 - PG – Four valuations - Two external's and two internal examiners.
- **Engineering:**
 - UG - Two valuations & Moderation valuation.
 - PG – Two valuations - One external and one internal examiner.
- Difference of more than 15% in theory answer script was subjected to third valuation in UG Medical & Dental.
Fifth valuation is done for PG Medical & Dental.
- Difference of more than 12% in theory answer script was subjected to third valuation in UG Engineering and difference of 10% in theory answer script was subjected to third valuation in PG Engineering.
- Results were announced in time (within 10 days on an average after completing practical exams)
- Retotaling option was given to students not satisfied with the marks for Medical & Dental.
- Revaluation in UG and Challenge Evaluation in PG option was given to students not satisfied with the marks for Engineering.
- Retotaling, Revaluation & Challenge Evaluation results were announced in time.
- Continuous efforts are being made to improve the system of conducting examinations
