Subject: Policy on Incentive and Awards for Research and Publication

Ref: Proceedings of Advisory Committee of R&D meeting held on 14/01/2019
vide Agenda No. SSAHE/R&D/20-II/2019.

Sri Siddhartha Academy of Higher Education has notifying the policy on Incentive and awards for research and publications to promote Research activities of the faculties at the constituent colleges of SSAHE.

1. Rationale:

The University aims to improve overall research performance and promote research activities undertaken by various departments/ faculty members and students. The Research Incentive Scheme (RIS) provides the means to assist with research activities or reward staff for successful publication or presentation of research outputs.

2. Incentive for publication

5. Paper Presentation in Conferences: Criteria for availing incentives:

- 1) Faculty should present paper / poster
- 2) Faculty can avail incentives for maximum of one conference per year
- 3) 50% of the Registration fees will be provided subject to maximum limit of Rs, 20,000/- per year
- 4) Heads of the Department of the constituent colleges can avail 50 % of Registration fee for attending any **One Conference** conducted in India once every five years without the need for presenting paper / poster. Subject to maximum limit of Rs.20,000/-
- 5) Registration fee will be reimbursed after submission of Certificate of attendance and original receipt of registration fee.

6. Project leading to Patent

The principal Investigator will be given cash award of Rs. 20,000/- and a certificate.

7. Incentives for Postgraduate and Undergraduate Students

- a) A reward of Rs.1,000/- for international publication and Rs.500/- for national publication in indexed journal as a first author.
- b) A reward of Rs.1,000/- for international project and Rs.500/- for national project as Principal Investigator with funds generated from outside. For postgraduate students, the project should not be duplication of dissertation.
- c) A reward of Rs. 1,000/- for Best Paper / poster award

8. Recognition for Faculties Getting International Research award:

A reward of Rs.20,000/- will be given along with certificate for international award received by faculty for their outstanding performance and innovative work.

9. Recognition for Faculties Getting National Research award

A reward of Rs.10,000/- will be given along with certificate for national award received by any faculty for their outstanding performance and innovative work.

10. Recognition for Faculties getting any regional or other award recognized by University

A reward of Rs.5,000/- will be given along with certificate for national award received by any faculty for their outstanding performance and innovative work.

11. Budding Researcher Award

Each Year University will give this award to one student, either postgraduate or undergraduate, for their outstanding performance in research. It will contain a certificate along with cash award of Rs.1,000/- after completion of research project.

The student should not be more than 30 years of age, should have at least 1 research paper in international or national referred indexed journals under his/her name as first author and at least 1 research project as PI with funding from outside agency apart from his dissertation work. If he/she is invited for presenting a paper he/she will be given incentives of Rs.1000/-

12. Young Researcher Award

Each year University will give this award to young researcher for their outstanding performance in research. It will consist of a certificate along with cash award of Rs.5,000/-. The researcher should not be more than 40 years of age, not above Associate Professor level, should have at least 3 research papers in international or national indexed journals under his/her name as first author and at least 2 project as PI with funding from outside agency.

13. Best Researcher Award

Each Year University will give this award to researcher for their outstanding performance in research. It will contain a certificate along with cash award of Rs. 15,000/- The researcher should have at least 03 international publications and 05 national publications in indexed journal under his/her name and at least 03 projects as PI with funding outside agency.

14. Incentives for organizing Research Conference of the students / by the students.

Student organizing conference every year by inviting experts from outside will be given financial assistance for organizing the conference.

15. International Level conference conducted by the College / Departments

- a) University will sponsor Rs.50,000/- to the constituent Colleges of SSAHE / Departments for conducting International Level Conferences
- b) University will sponsor Rs. 20,000/- to the constituent Colleges of SSAHE / Departments for conducting National / State Level Conferences.

16. Conduct of Seminar / Training of Trainers (ToT) / Continuing Medical Education (CME) / Continuing Dental Education (CDE) / Guest Lecture programmes / Workshops / Faculty Development Programme / Symposium.

University will sponsor Rs. 5,000/- per programme (maximum of five per year per constituent colleges) to the constituent Colleges of SSAHE / Departments for conducting Seminar / CME/CDE/ToT/Guest Lecture/Workshops/ Faculty Development Programme / Symposium.

17. Book/ Book Chapter/ Monograph

The e-book and hard copy books are considered for research incentive. The pocket books or booklets and books having less than 20 pages are not considered for research incentive.

- I. For each Book (Reference or Text) authored/edited singly or jointly and published by International Publisher (McGraw Hills, Tayler Francis, Springer, Elsevier, CBS Publisher etc. or Apex bodies/Societies with ISBN (International Standard Book Number), the Authors/Editors will be given one time incentive maximum of Rs. 30,000/-
- II. For each Book (Reference or Text) authored/edited singly or jointly and published by SSAHE / National Publisher (McGraw Hills India, JP publisher, Springer India, Elsevier India, CBS Publisher etc. with ISBN, the Authors/Editors will be given one time incentive maximum of Rs. 20,000/-

- III. For each Book (Reference or Text) authored/edited singly or jointly and published by Local/ Regional Publisher with ISBN, the Authors/Editors will be given one time incentive maximum of Rs. 15,000/-
- IV. For each "Chapter/ monograph" in Book published by International Publisher with ISBN, the Author/s will be given one time incentive maximum of Rs. 10,000/-
- V. For each "Chapter/monograph" in Book published by National Publisher with ISBN, the author/s will be given one time incentive maximum of Rs. 8,000/-

18. Patent Granted:

The incentive maximum of Rs. 50,000/- for International and maximum of Rs. 25,000/- for Indian Patent will be given for successfully granted patent. For more than one investigator, the disbursement of incentive will be as per Advisory Committee of R&D

Note: All research proposal project / claiming of incentives / conducting research activities / conducting CME/CDE/TOP etc., must submit to The Coordinator (R&D), SSAHE for further actions through institutional Peer Review Committee or Institutional Research Committee.
