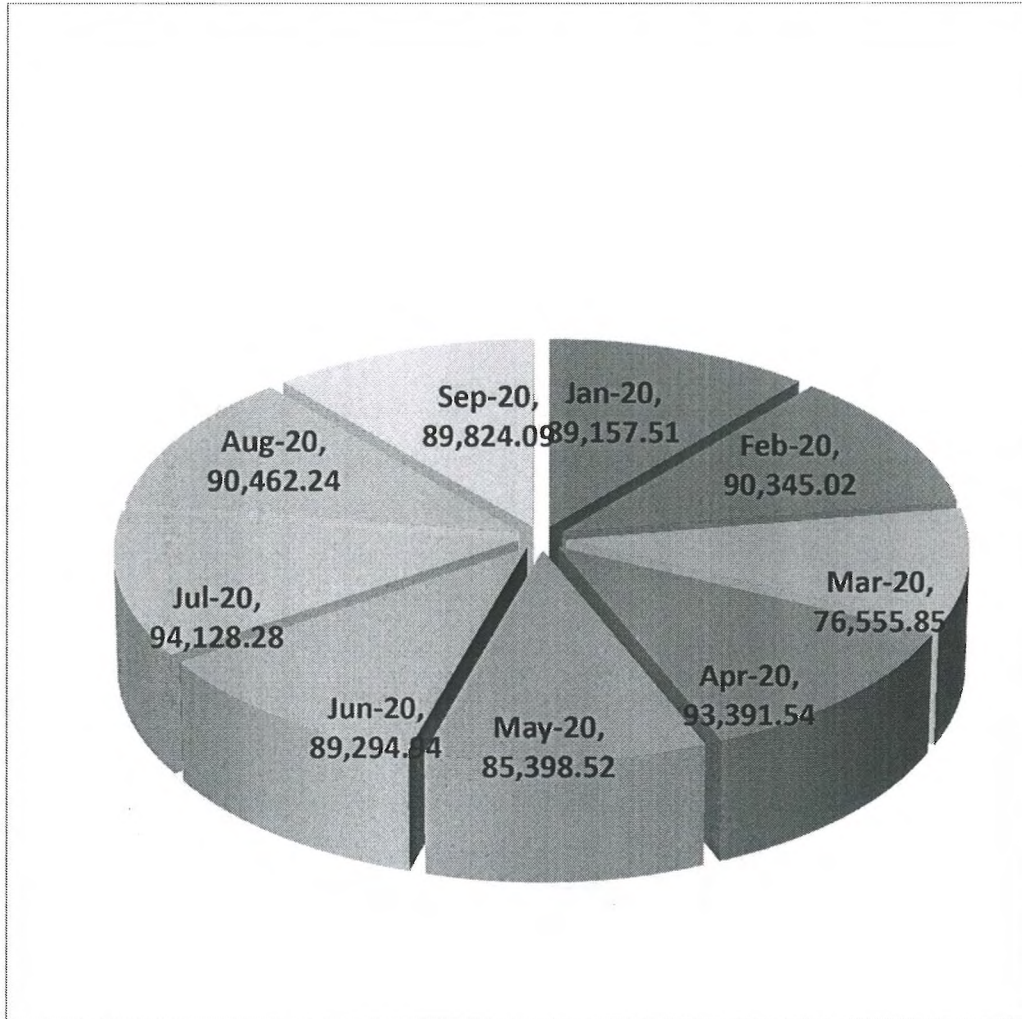

- Replacing all Laser Printers by Ink-jet Printers.
- Replacing CRT monitors of PC's with LED monitors.
- Replacing old UPS by energy efficient UPS.
- Regular maintenance of batteries.
- Automate your appliances with smart assistants.
- Bring in more natural light with mirrors and bright walls.
- Switch out incandescent lights.
- Unplug battery chargers when not in use.
- Automate thermostat according to the time of day.
- Set your computer to sleep or hibernate mode when not in use.
- Use electric kettle to boil water instead of a microwave in hostels and guest houses.
- Install low-flow shower heads in hostels.
- Additional APFC been recommended to maintain quality power.
