## Board of Studies

As per the discussions in the meeting of Board of Studies, Sri Siddhartha Dental College conducted on 25/07/2018; the following proposal is conveyed to the Academic Council SSAHE, Tumkur.

1. We request the university to de-notify the proposed supplementary exams for I BDS 2017 batch of students due to various reasons. One of the reasons being it has not been mentioned in DCI regulations & may lead to legal eventualities later & disturb the academic progress of the said students.

2. The student should compulsorily give Part I examination at the end of 1<sup>st</sup> year.

**Reference:** As per DCI 2017 MDS regulations, Page 54 (Line 44 & 45), Page 55 (Line 6 – 10, 21 & 22, 32 - 34), Page 56 (Line 8).

Internals for Part I paper of I MDS students (2018-19 Batch) is scheduled as

- 1<sup>st</sup> internals to be conducted at 6 months
- 2<sup>nd</sup> internals to be conducted at the end of 9 months.
- The Internals paper will be set by the concerned dental subject experts.

80% of the attendance is compulsory for appearing in the Part I University Examination paper.

3. As per DCI 2017 MDS regulations, page no 54 (Line 34 – 37) it has been mentioned PG Practical / Clinical examinations in all the specialities to be conducted for six candidates in two days which also includes examination of Prosthodontics Practical / Clinical to be conducted in two days.
