### **MEMORANDUM OF UNDERSTANDING**

**Memorandum of Understanding (MoU)** is made between **Sri Siddhartha Medical College and Hospital and Jivva MRI Centre Pvt Ltd** entered into on **1<sup>st</sup> Day of May, 2025** for investigation services during equipment breakdown for Radiology imaging, CT scan and MRI services for provision of radiology diagnostic services.

**The Principal, Sri Siddhartha Medical College and Hospital, Agalakote, B.H. Road, Tumkur – 572107 and Managing Director, Jivva MRI Centre Pvt Ltd, 7/7, K Mallanna Complex, Railway Station Road, Tumkur - 572102** agree that in the event of a catastrophic medical emergency or during equipment breakdown in the **Sri Siddhartha Medical College and Hospital** an alternate care site and necessary resources will be quickly provided by **Jivva MRI Centre Pvt Ltd**.

**Sri Siddhartha Medical College and Hospital, Tumkur and Jivva MRI Centre Pvt Ltd, Tumkur** enter into the agreement as follows:


1. Facility space: **Sri Siddhartha Medical College and Hospital** accepts designated **Jivva MRI Centre Pvt Ltd**, located at **7/7, K MALLANNA COMPLEX, Railway Station Rd, Tumkur – 572102** as an alternate care site in the event of catastrophic emergency.
2. Use of Facility: Request to use facility as an alternate care site will occur as soon as possible through the local emergency operations center. Designation and use by **Sri Siddhartha Medical College and Hospital** will be mutually agreed upon by all parties to this agreement.

3. Modification or Suspension of normal facility business activities: **Jivva MRI Centre Pvt Ltd** agrees to alter or suspend normal operations in support of the alternate care site as needed.
4. Cost: All reasonable and eligible costs associated with the emergency and the operation of alternate care site that include treatment of patients admitted shall be borne by the **Sri Siddhartha Medical College and Hospital**.
5. All the costs of the services shall be as per CGHS tariff and services may be availed at **Jivva MRI Centre Pvt Ltd** on credit by **Sri Siddhartha Medical College and Hospital**.
6. Contact Information: **Sri Siddhartha Medical College and Hospital** will provide **Jivva MRI Centre Pvt Ltd** the appropriate facility 24/7 day contact information and update this information as necessary.
7. Terms and conditions:
  - A. During mass casualty, patients shall be shifted by **Sri Siddhartha Medical College and Hospital** to **Jivva MRI Centre Pvt Ltd** in ambulance as applicable and the rates payable by **Sri Siddhartha Medical College and Hospital** to **Jivva MRI Centre PVT LTD** is on a mutually agreeable basis from time to time.
  - B. During breakdown of radiology equipment (X-Ray, CT, MRI, USG etc.), the patients are to be physically sent to **Jivva MRI Centre Pvt Ltd** facility for the test and the report of the same shall be sent to **Sri Siddhartha Medical College and Hospital** within 3 to 6 hours after the tests are done.
  - C. The peer review of Radiology reports: The radiology films shall be sent by **Sri Siddhartha Medical College and Hospital** to **Jivva MRI Centre Pvt Ltd** for the external peer review on quarterly basis

and Jivva MRI Centre Pvt Ltd shall be reporting the radiology films within 15 days of receipt. The above services shall be charged by Jivva MRI Centre Pvt Ltd to Sri Siddhartha Medical College and Hospital on mutually agreeable basis from time to time.

8. Duration of Agreement: The minimum term of this MoU is 3 years from the date of the initial agreement. Subsequent terms may be longer with the concurrence of two parties.


9. Agreement Review: A review will be conducted by Sri Siddhartha Medical College and Hospital following a disaster event or within one year after the effective date of this agreement. At that time, this agreement may be negotiated for renewal. Any changes at the facility that could impact the execution of this agreement will be conveyed to the identified primary contacts or their designees of this agreement as soon as possible. All significant communications between the parties shall be made through the primary contact or their designees.

10. Amendments: This agreement may be amended at any time by signature approval of the signatories or their respective designees.

11. Termination of agreement: Any party may withdraw at any time from this MoU, except as stipulated above, by transmitting a signed statement to that effect to the other parties. This MoU and the partnership created thereby will be considered terminated thirty (30) days from the date the non withdrawing party receives the notice of withdrawal from the withdrawing party.

12. Capacity to enter into agreement: The persons executing this MoU on behalf of their respective entities here by represent and warrant that they have the right, power, legal capacity and
